Mid-term Report & Review

- Beginning July, we submitted our Mid-term Report to the Commission
- Mid July, our progress was reviewed by an external commission (Nazim Gruda, University of Bonn, Humboldt University of Berlin & Mary Taylor, Taylor AgriConsult) in an online session with the ExCom
- In September and October, 2 updates of the Mid-term report were send to the Commission, mainly to clear some remaining financial issues
- Beginning November, we received the Review Report which, in general, was very positive about the progress that we have made:
- "Overall outputs achieved are significant and in line with the overall objective of developing a roadmap for futureproofing the food system and the European economy"



Mid-term Report & Review (2)

- The Review Committee made the following recommendations:
- "A first recommendation is the introduction of a concrete success control with quantitative approaches for the parameters in the scope of the project. For instance, for yield, a starting base for different crops cultivated in greenhouses and/or open field has to be introduced in the database"
- "A second recommendation relates to considering the **types of agricultural systems** for the future to ensure that trade-offs between sustainability, quality, and yield, and the crops are considered."
- "As a third recommendation, the need to combine the so-called soft measures, such as explanation, training, education, dissemination etc. with recommendations for hard measures, such as taxation and legislation, if any should be addressed." (climate change, COVID-19)
- "A fourth recommendation is the intensification of communication and dissemination of results"



Mid-term Report & Review (3)

- We now have till end of November to send our reactions on the review report, if any, to the Commission.
- Thereafter, the Mid-term Report will be considered as final, and payments will be made within 90 days thereafter.



COVID-19 Contingency Planning

- In consultation with the Commission, a COVID-19 Contingency Planning was made in March:
- All workshops and other meetings were replaced by online events
- A number of Milestones and Deliverables were shifted backwards due to encountered delays
- An Contract Amendment was made allowing the re-allocation of Person Months of 2 partners (EPSO and ACTA), and allowing a budget change for partner WU from 'other direct costs" to "personnel cost"
- Further contingency planning now is needed in relation to the second Corona-wave that hit Europe after summer, and a new Contract Amendment is required.
